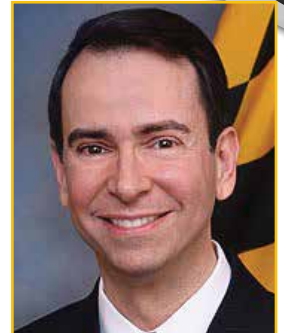

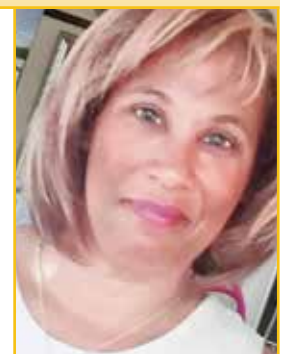

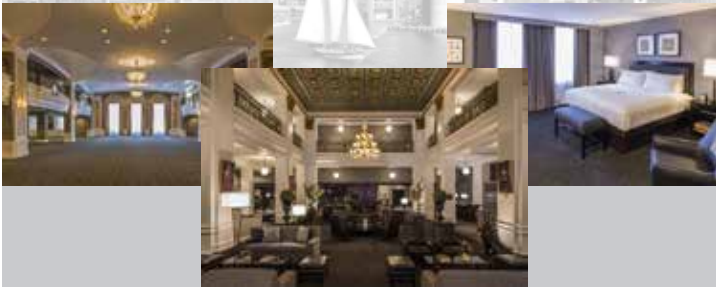

Three deeply involved community members affirmed to the value of Touchpoint from their experience in *The Power of TouchPoint* with Jackie Caldwell, President, Greater Mondawmin Coordinating Council and Community Liaison for TouchPoint Baltimore at Mondawmin; Jim Foster, Baseball Coach, Frederick Douglass High School; and Helene Kahn, Manager of Partnership Development and Volunteer Recruitment, Thread.

After a bus ride across town, the class enjoyed a tour of the future with an overview and tour of Port Covington by Demian Costa, Managing Partner, Sagamore Ventures and Matthew C. Rienzo, Development Executive, Sagamore Development Company. After a long day, the class bussed back to the Lord Baltimore Hotel for a lovely dinner in the French Kitchen and an energetic, if brief, night on the town by some.

The next morning, and following the always creative and engaging Perceptions and Realities presentation by the Central Region Team, the class boarded the bus for a quick trip to the University of Maryland Medical System (UMMS) where Karen E. Wrapping up the day, the class bussed over to Living Classrooms, founded by the visionary **James Piper Bond ‘95**, for lunch and a tour. Several staff members and participants explained that Living Classrooms teaches woodworking, maritime, and life skills to Baltimore’s at-risk youth at their self-built workshop facilities on the Harbor’s waterfront. This theme would remain in their mind for the whole year.

Next was a quick but refreshing stop at the iconic Lakeside Creamery hosted by "Ice Cream Bill" **Bill Meagher '11** where the class enjoyed ice cream and hand-dipped donuts.

Layton '14**, Joseph H. Layton, Jr., Owner, Lazy Day Farms and William Layton, Winemaker, at Layton's Chance. Straight talk, a tractor ride, and lots of sampling of product made for a mellow and memorable evening.

The next morning started with following the chicken through a tour of the Perdue's Salisbury Processing Facility, the original facility where Perdue was created. Then the class visited the Franklin P. Perdue School of Business for a session on *Perdue and Its Future* hosted by **Dr. James A. "Jim" Perdue '00**, Chairman of the famous family-owned business. Dr. Janet Dudley-Eshbach, President, Salisbury University, hosted the class for lunch in the Commons immediately followed by the ever-fascinating **Dr. Memo F. Diriker '12 (LM)**, Professor and Director of BEACON discussing *Shore Trends and Graying of the Shore*.
